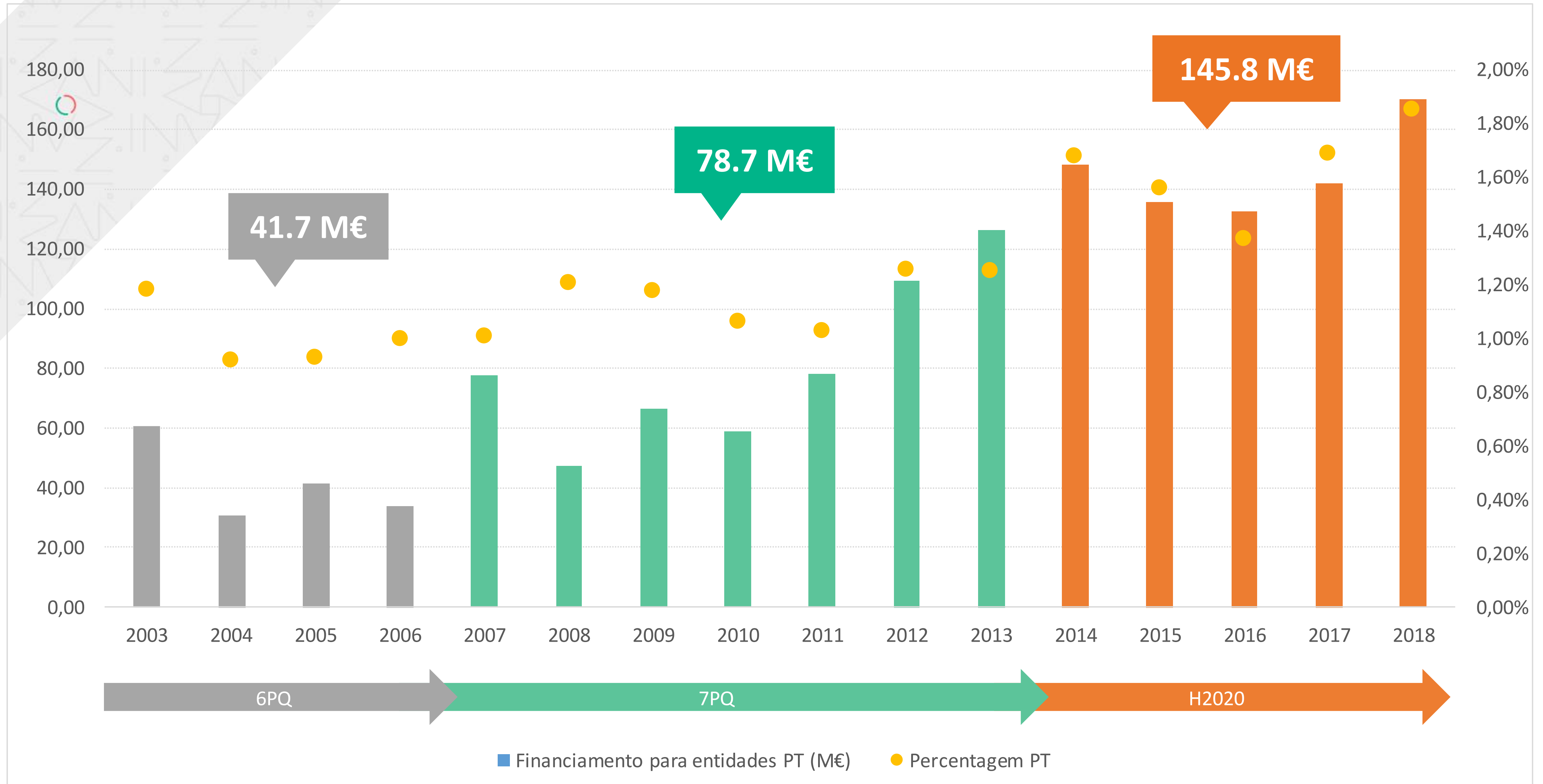

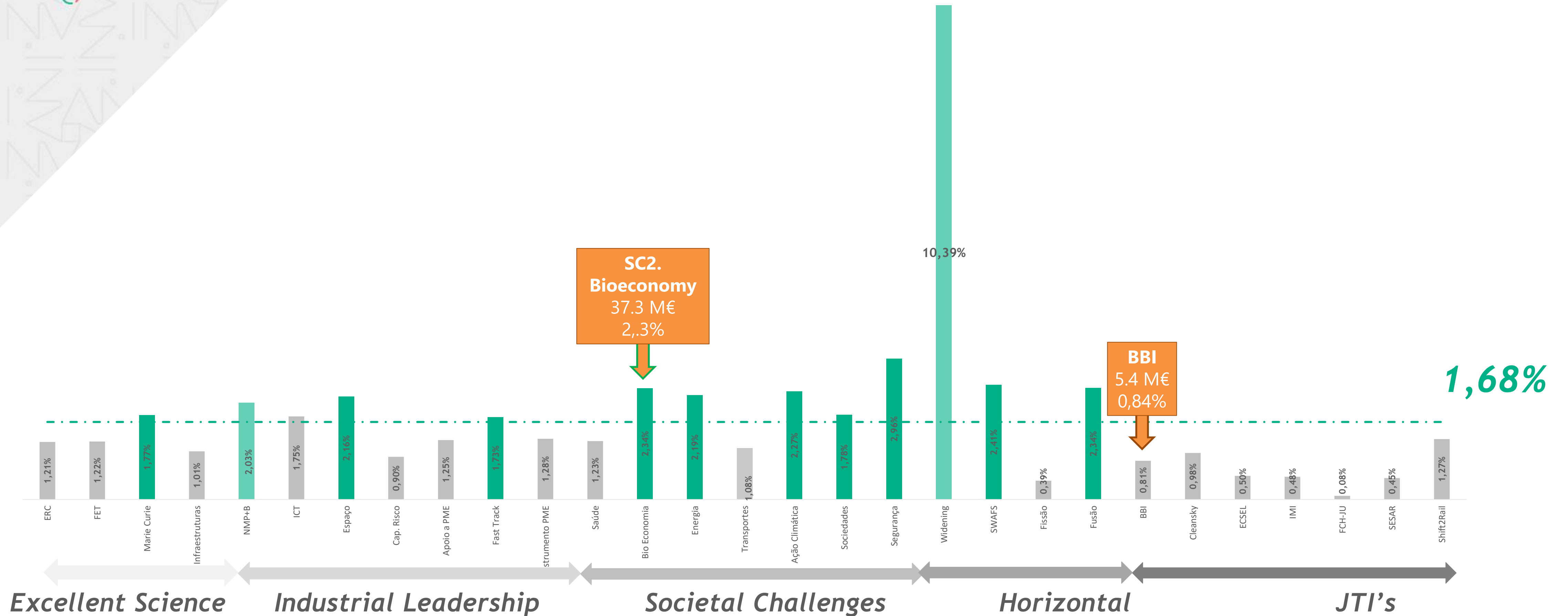
Evolution of PT participation





PT participation in H2020

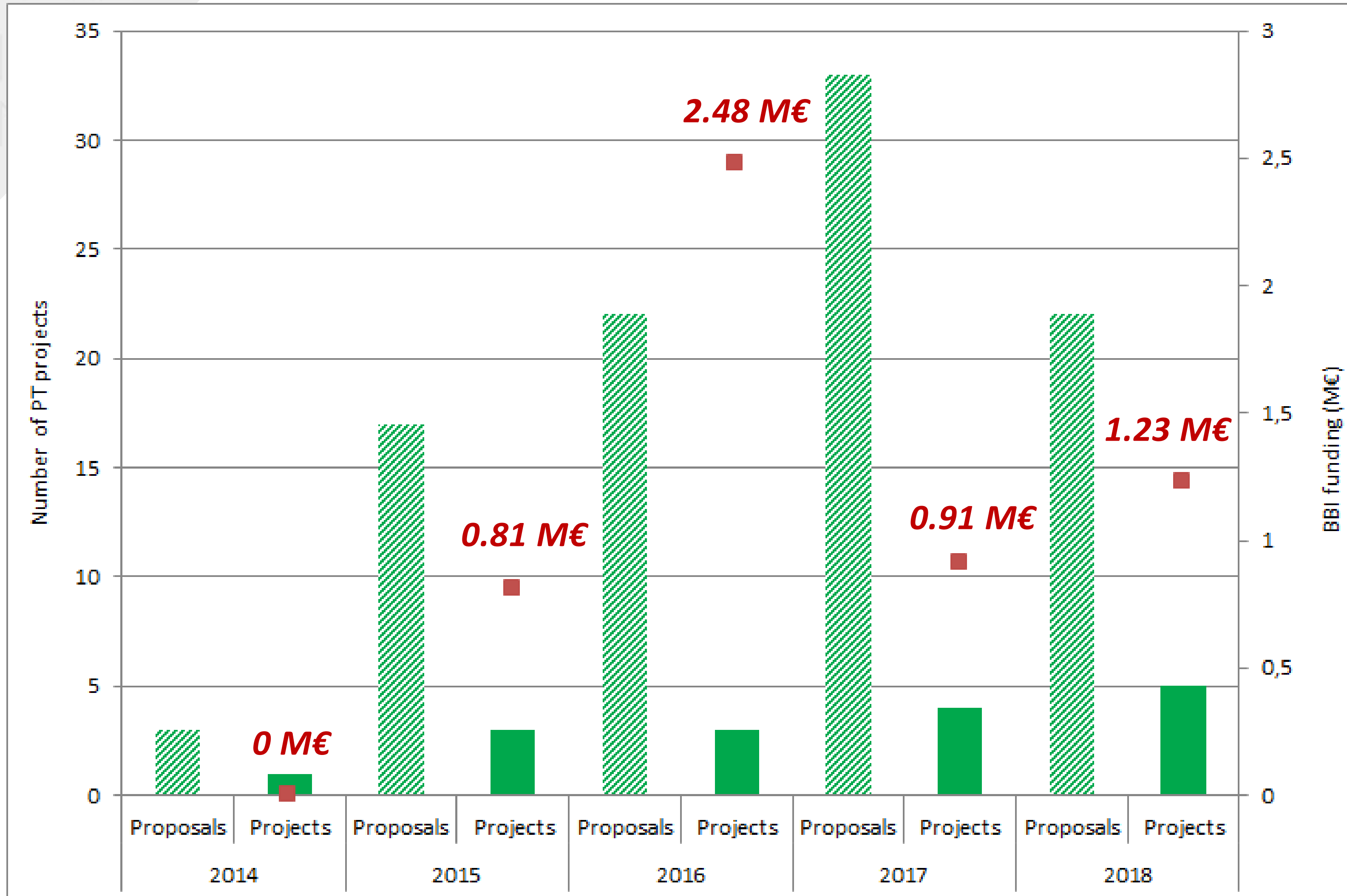
2014-2019* (provisional data)

Total fundig to PT entities



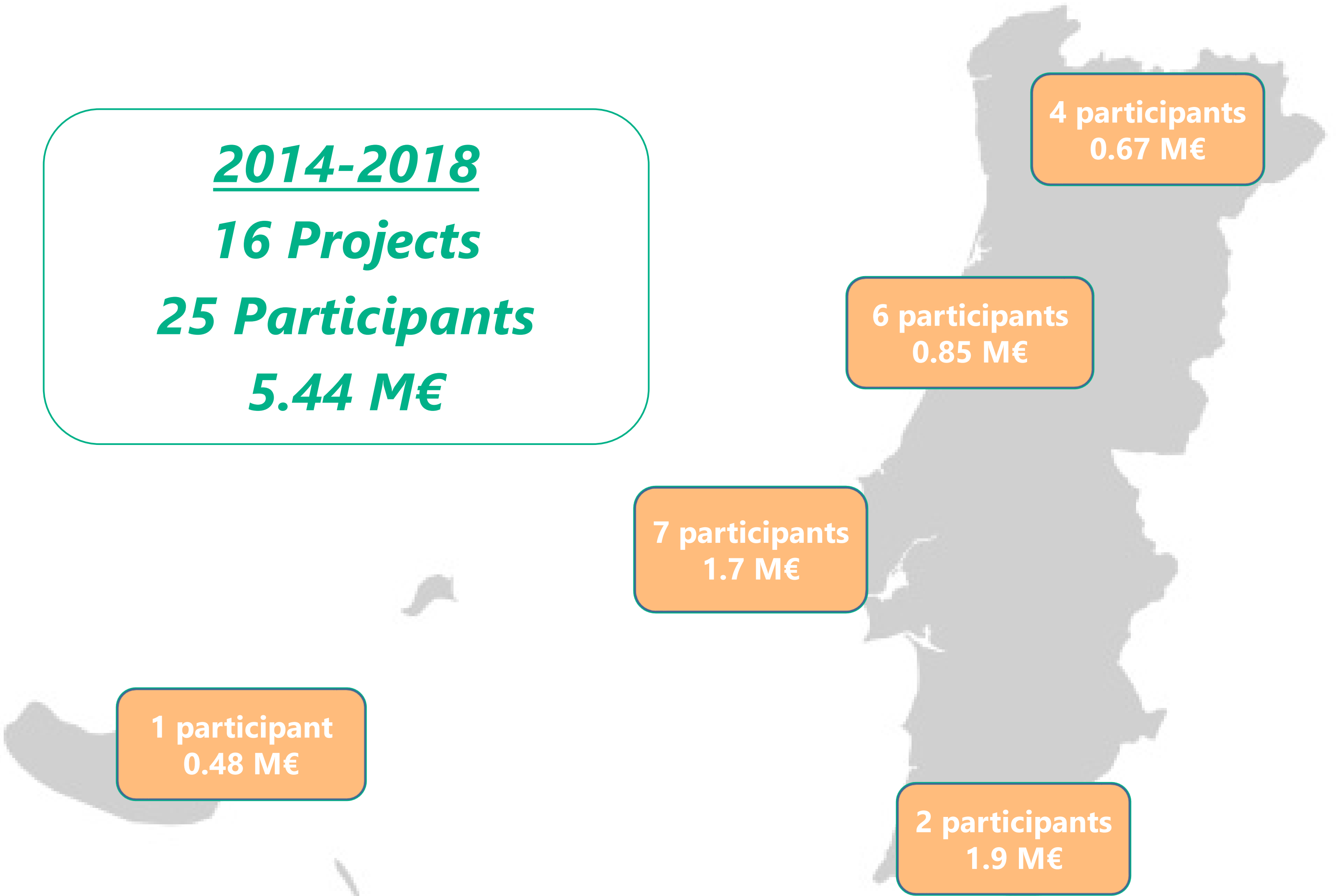

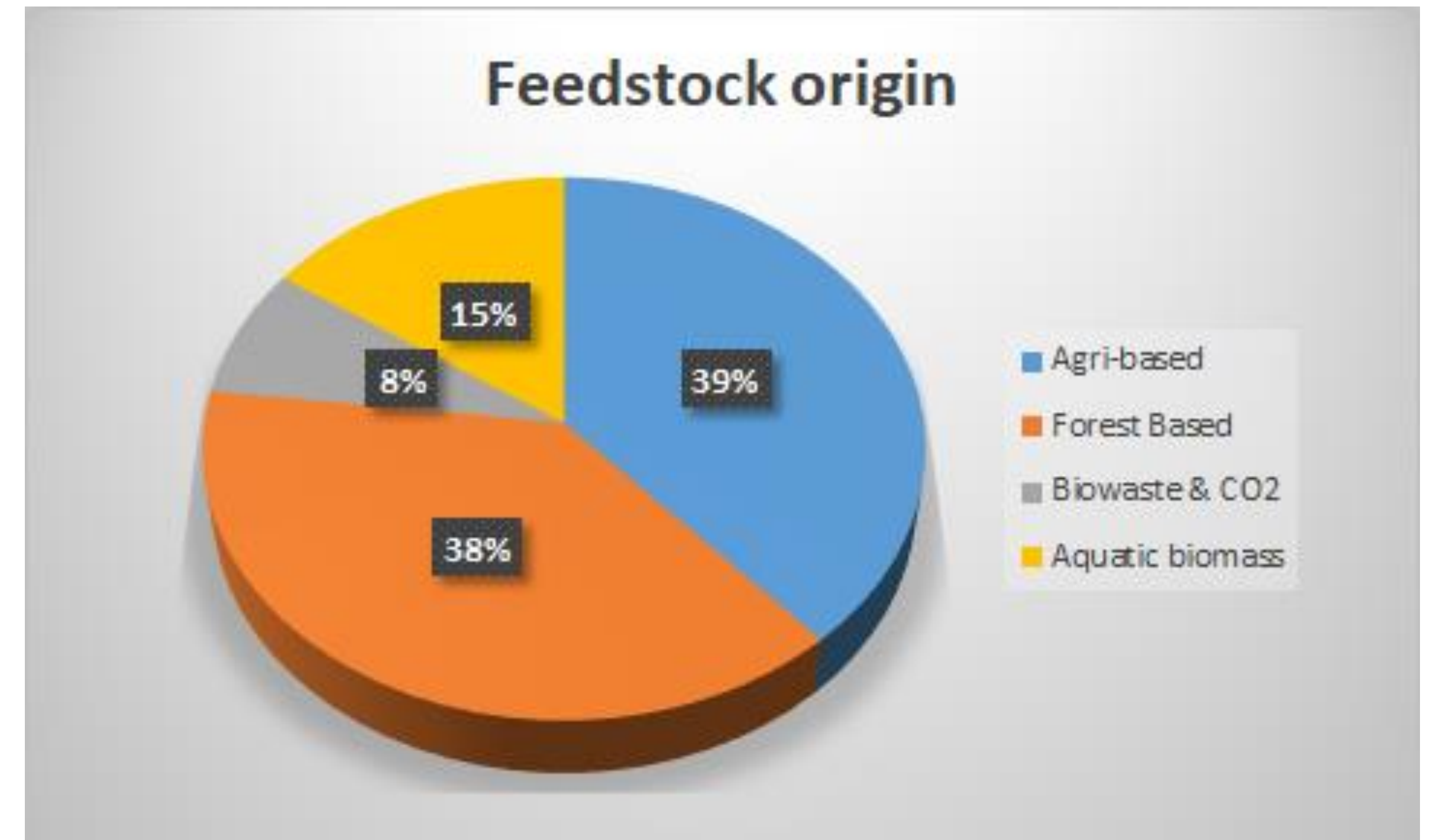

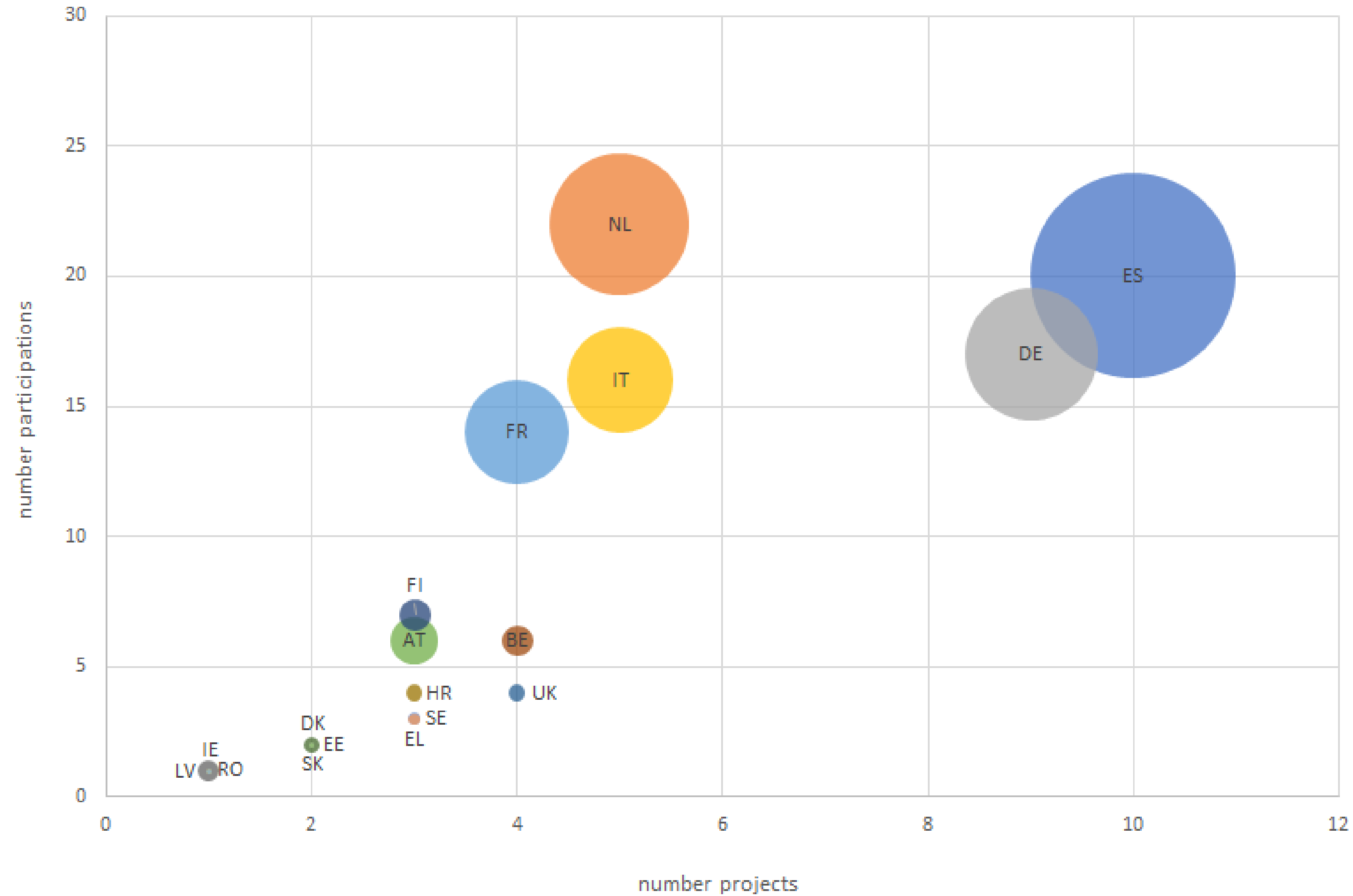




Network of PT collaborations in BBI JU projects
