





- NCP's (host + outgoing)/Infodays
- Institutional Research Offices
- EU Comission
- Other institutions
- Panoply of information on the web (videos on youtube, .ppt, .pdf) important not to get lost!!

Tip # 2: Allocate appropriate amount of time to write the proposal

- Contingency plan
- Tip #3: Keywords
  - Interdisciplinary / multidisciplinary aspects
  - Complementary skills
  - Career development / professional maturity
  - Innovation / competitiveness
  - Excellence (researcher / host institution)
- Tip # 4: Know your project very well!

- Tip #5: Resubmissions Address ALL weaknesses pointed out in the Evaluation Report (very useful!!)
  - Too ambitious goals for time frame
  - Specify formal courses (too much reliance on informal training)
  - Limited teaching experience
  - Relatively modest publication record
  - Include IPR Agreement
  - Lack of specificity explaining how newly acquired skills and competences will be transferred to the return host
  - Potential contribution to European excellence is not fully substantiated
- Tip #6: Be very clear, straigthforward (don't be vague!)
- Tip #7: Get the proposal reviewed by as many (relevant, experienced) players as you can (distinct views on whether or not to mention it was resubmission)
- Tip #8: Don't give up and don't get discouraged!
