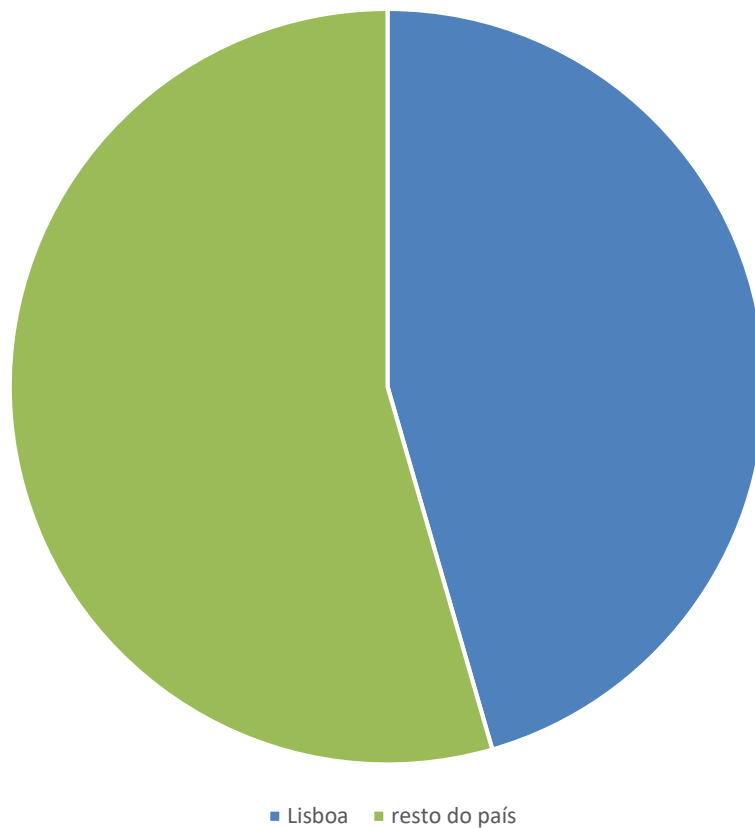

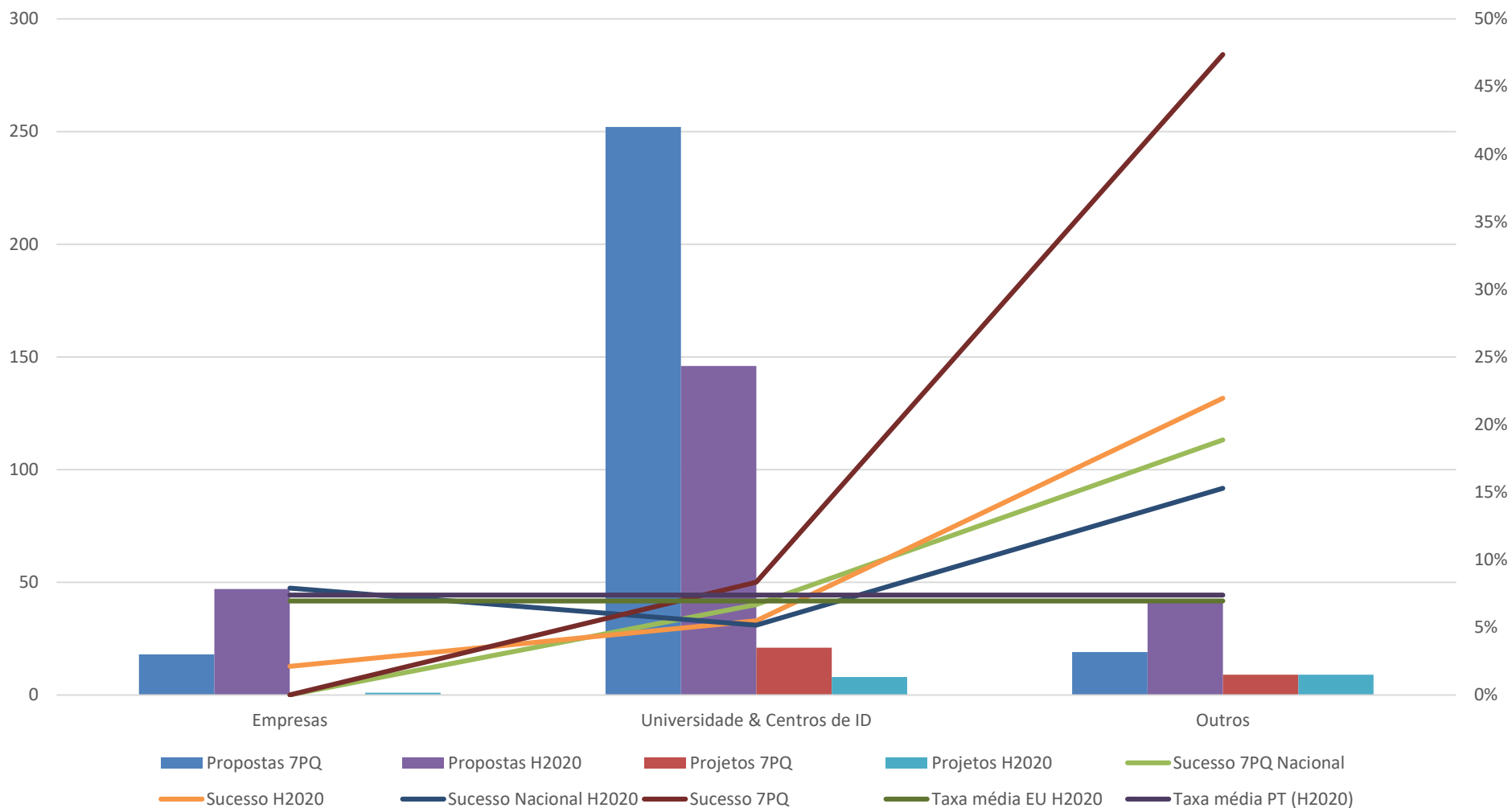

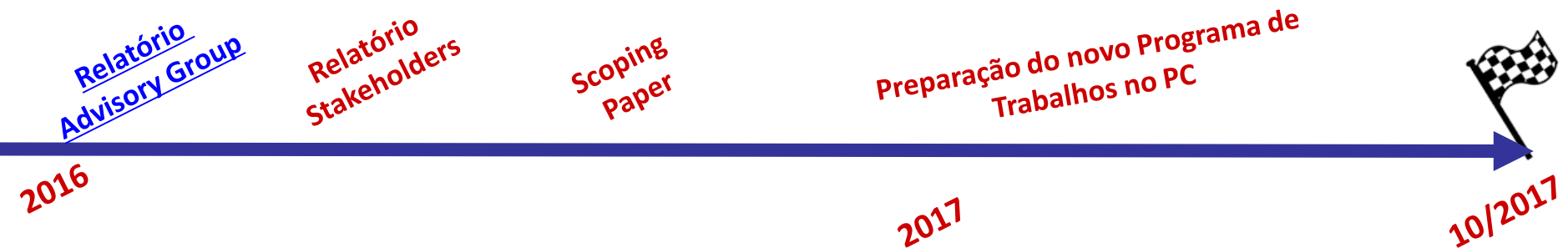

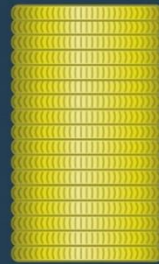

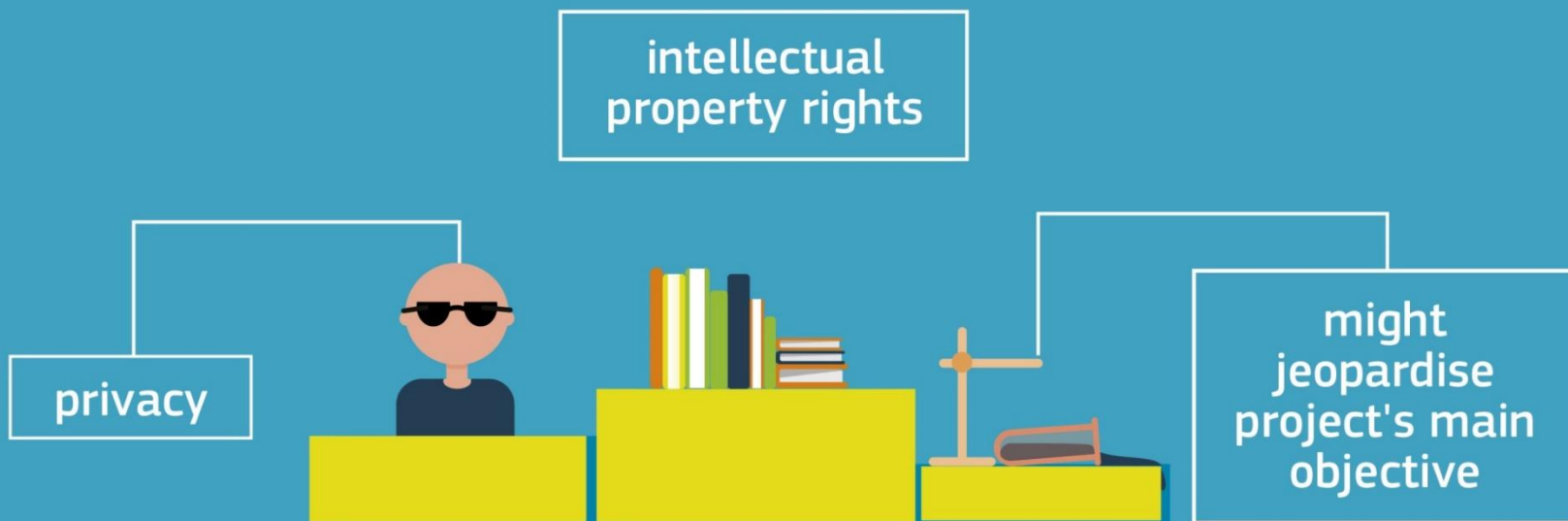

- **Impacto limitado no fortalecimento da competitividade e crescimento das empresas”**.
- A abordagem da proposta e a forma como permite alcançar o impacto esperado **não está suportada em exemplos convincentes**.
- É fornecida **informação insuficiente sobre o potencial impacto na excelência e competitividade global e Europeia**.
- A proposta **não explica nem justifica adequadamente os benefícios económicos**.

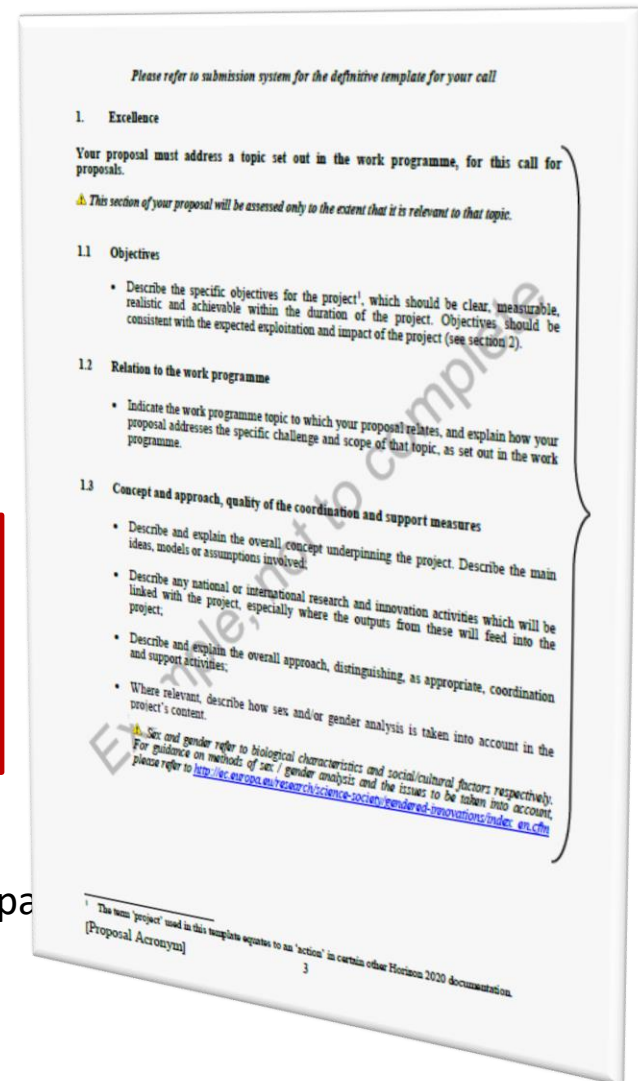

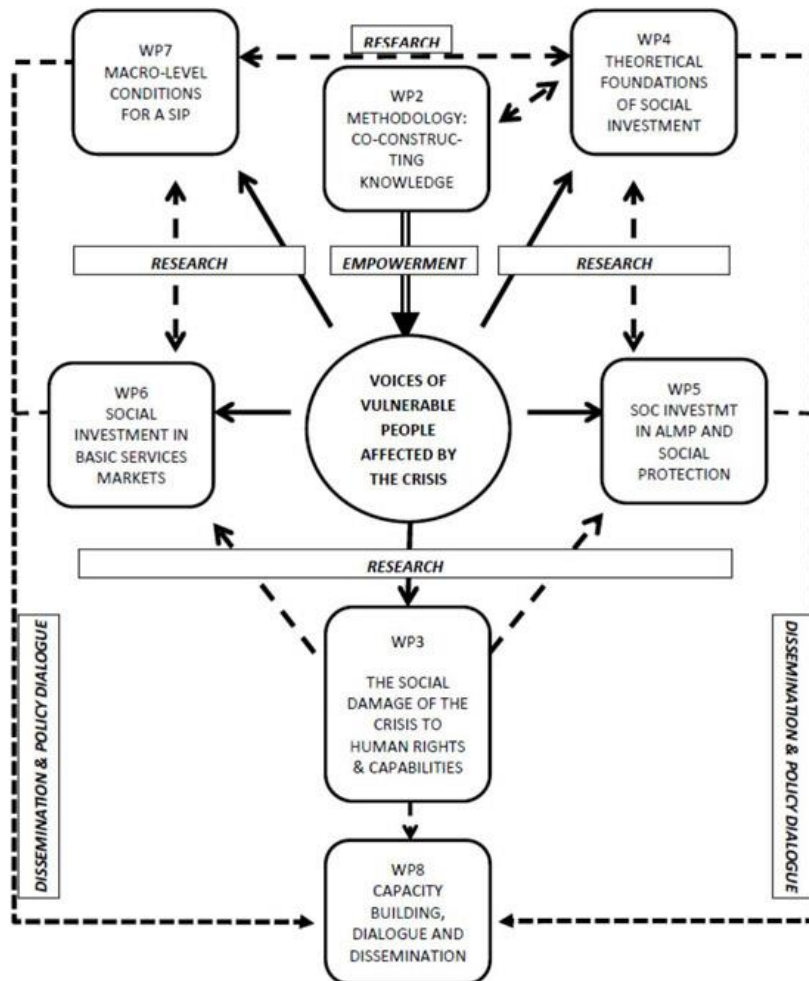


Diagrama de PERT

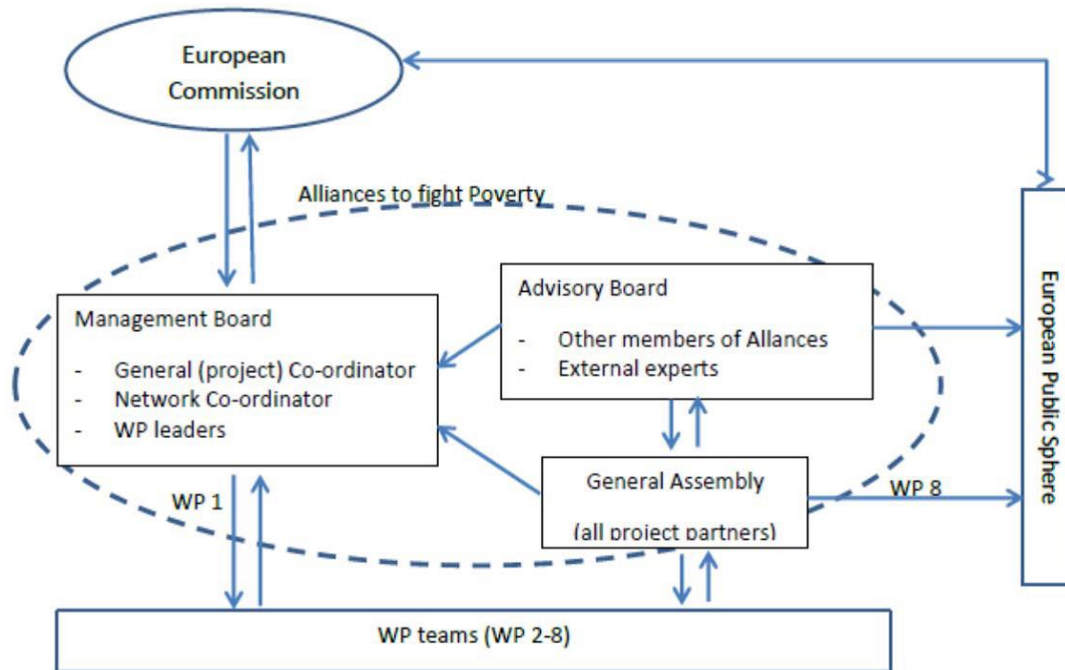
Gantt Chart

- Existem **demasiadas tarefas e recursos** concentradas num WP.
- Algumas descrições de tarefas **não estão suficientemente detalhadas**.
- O **timing projetado é problemático**, com tarefas que se alimentam a decorrer simultaneamente.
- Os **recursos pedidos não estão bem justificados**
- A proposta lista **poucos milestones** face à duração do projeto
- O **plano de contingência** não responde ao riscos identificados

 - ✓ Procure apoio na sua instituição desde o início
- ✓ A proposta deverá facilitar a leitura pelo avaliador
 - ✓ Use **negrito**, diagramas, *bulletpoints*, etc...
 - ✓ Seja direto desde o início: identifique o que será feito, de que forma será feito, e estabeleça uma ligação clara com o tópico – particularmente com o *scope* e impacto esperado.

ASPECTOS A CONSIDERAR NA ELABORAÇÃO DA PROPOSTA

- ✓ Seja rigoroso ao preencher a Ethics Table na parte A e a responder a estas questões no formulário (em anexo deverão seguir os documentos de suporte).
- ✓ Preste atenção ao abstract – é com base neste abstract que as propostas são distribuídas entre os avaliadores
- ✓ Dê a sua proposta a ler a colegas.
- ✓ Envie a sua proposta para o NCP

ASPECTOS A CONSIDERAR NA ELABORAÇÃO DA PROPOSTA

- ✓ O plano de trabalhos deve ser credível e exequível
 - ✓ Adequação aos objetivos definidos
 - ✓ Descrição detalhada das tarefas – incluindo deliverables e milestones de cada WP
 - ✓ Definição dos recursos necessários à execução das tarefas
 - ✓ Enquadramento do WP no tempo de vida no projeto
 - ✓ Parceiros envolvidos no WP e respetivas tarefas – competências, experiência anterior...
 - ✓ Os diferentes WP devem formar um conjunto coeso e interligado, projetado de forma clara ao longo do ciclo de vida do projeto

ASPECTOS A CONSIDERAR NA ELABORAÇÃO DO ORÇAMENTO

- ✓ PM -> custos reais
- ✓ Adequação dos recursos às tarefas.
