
**OneGeologyEurope**; Surface geology of Europe in 1:1 mil. Using distributed architecture, including ISO19115 metadata and WMS/ WFS (GeoSciML) services **PanGeo**; Ground instability assessment of major European cities using PSI data from satellite in combination with in situ data



**Mineral deposits**; Compiled and harmonised through a number of projects (ProMine, EuroGeoSource, Minerals4EU) using distributed architectures, ISO, OGC and CGI standards



**EMODnet-geology**; Marine substrate map. Currently in 1: 1 million, but aiming for 1: 250 000 covering all European waters



**GEMAS**; geochemical mapping of agricultural and grazing land soils of Europe




